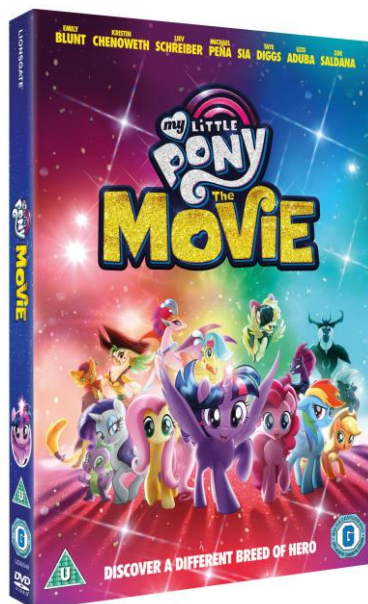

## TERMS AND CONDITIONS:
